### TERMS AND CONDITIONS

#### 1. APPLICATION PROCESS OVERVIEW:

Entrants must complete the above application form and make a submission, making their case for the award of the scholarship. Application forms can be submitted by email or by post. If entrants cannot access the NCI website an application form can be forwarded to them by post. For more details see section 3: How to apply (below).

Applications will be accepted up to 5pm on the 31st May 2025. The recipients and unsuccessful applicants of the scholarships will be notified by e-mail. Please read all of the scholarship rules and additional information provided below prior to entering. By submitting an application, you are accepting the terms and conditions of the scholarship.

#### 2. ELIGIBILITY:

The scholarship is open to female applicants who must meet the academic eligibility requirements for the proposed course, which will typically require an undergraduate degree for access to a postgraduate programme.

Employees of National College of Ireland, and the spouses, immediate family members, dependents, and/or other persons living in the same household, are not eligible to participate.

By submitting an application, entrants agree and consent to their personal details, full name, area of residence, photographs and biographical information (in whole or in part), being published on the NCI website and in NCI publications, and other marketing material.

#### 3. HOW TO APPLY:

#### 4. JUDGING AND SELECTION OF WINNERS:

Applications will be judged by a panel of adjudicators, and applicants may be required to attend an interview with the panel so that the successful applicant can be chosen.

*Judging will be based on the following criteria:*

1. The genuine desire of the entrant to further their education
2. The impact of the scholarship on their life

#### 5. SCHOLARSHIP DETAILS

The scholarship covers all enrollment fees net of any additional grant funding (in respect of fees) that the student may have secured. It does not cover books, materials, computers, travel or subsistence costs. The scholarship is available for the listed postgraduate business courses. It cannot be used for other courses nor exchanged for cash or other alternatives. All courses run subject to numbers. If a course is not eligible to run, NCI will make an offer for an alternative postgraduate taught master's programme in a cognate field where possible. If the applicant deems this alternative course unsuitable or no alternative can be offered, NCI will rescind the awarding of the scholarship.

#### 6. WINNER NOTIFICATION

The recipient of the scholarship will be informed by e-mail, using the address details provided in their application form.

#### 7. SCHOLARSHIP REDEMPTION

In order to redeem their scholarship the individual must comply with the programme entry requirements for their chosen course of study, timeline and the application process at National College of Ireland.
